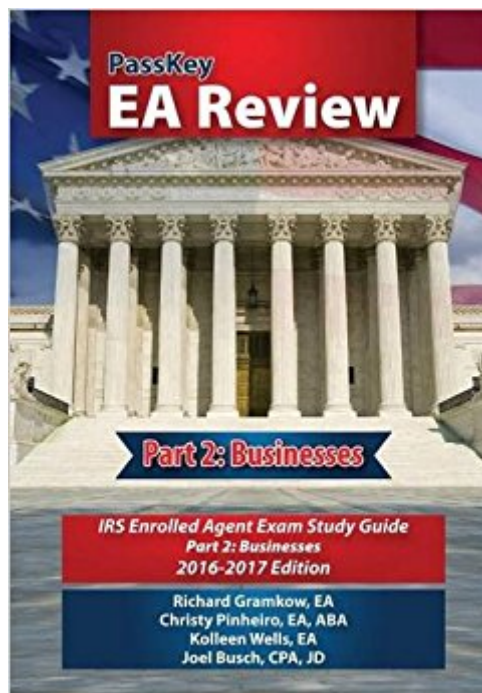

I do not have any background in business tax. The only resource I had for the exam was this book. I just took the exam today and passed. I felt this book did a tremendous job of preparing me for the exam and I did not spend any additional money on review materials. This book is the only thing I used. Like other reviews mentioned. there certainly were questions on the exam that were not touched upon in this book. For those questions, I made an educated guess by eliminating some answers. Others, I literally had no idea what the answer could be. To expect a book to prepare you for EVERYTHING the test is going to test on would be impossible. At the end of the day, this book is ideal if you can learn well from simply reading.

I don't normally write reviews, but I felt it was necessary to help others about to take this exam. I

almost purchased the expensive Gleim materials, and I am so glad I didn't. I don't even think the online learning offered by Passkey is worth the money, so you know this is an unbiased review. All you need to do is study the books, and then go over the last 4 years of exams provided by the IRS (2002-2005). 1. Read the chapter 2. Read the chapter and highlight your weak areas 3. Read your highlighted text 4. Take the end of chapter exam 5. Repeat above for each chapter 6. After finishing the book, skim read your highlighted text, and take notes on weak areas 7. Take the 2002-2005 IRS practice exams 8. Repeatedly practice the IRS practice exam questions that give you trouble 9. Pass the exam! I passed all 3 of the exams after studying for less than 2 months while working full time. I do NOT have an accounting background, but I am a financial advisor so that helped on some subjects. I do feel that no matter what your background, anyone with average intelligence that puts in the time will be able to pass the exams using only the passkey books. Good luck to you!

This is a very good book as are all of the PassKey books particularly for the Enrolled Agents exam. I know for a fact I will pass the EA Part 1 exam on the 1st try as I did with the EA Part 3 Passkey book. These authors do an absolutely lovely job explaining things and the font is medium sized so it's easy to read.
