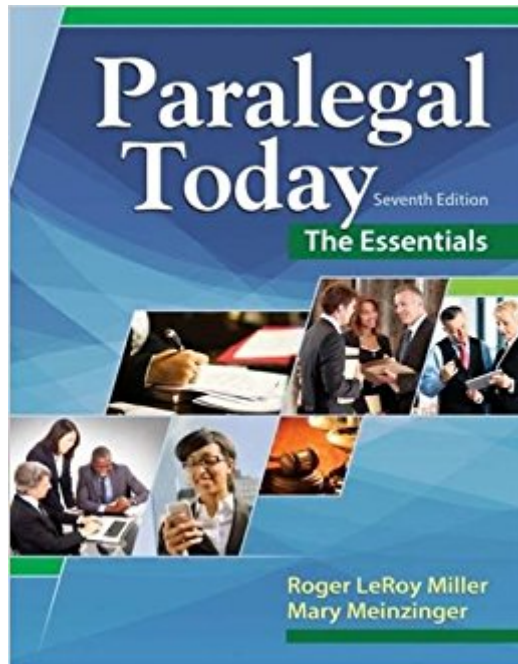

This is an abbreviated form of the red-cover book. This copy only contains 12 chapters, rather than

the entire 19. However, there is no indication on the website when one goes to buy a copy. So if your class requires the hard cover, and you think that getting the soft-copy will be good enough, DO NOT get this. It is only going to end up costing you more money because you will have to also get the hard cover book. There is no indication on the website that identifies this as an abbreviated text.
